 - #3: Should the Safety Committee remain a stand-alone committee
 - #4: Would you be more likely to attend a Business/Expo meeting if there were specific safety sessions?

Safety Committee Member Survey

- Survey Results were shared with the committee.
 - #1: What would you like from the Safety Committee – **Education**
 - #2: Which topics do you find most beneficial – **Policies and Training**
 - #3: Should the Safety Committee remain a stand-alone committee - **Yes**
 - #4: Would you be more likely to attend a Business/Expo meeting if there were specific safety sessions? – **Yes**
- From these results, the Building Blocks of Safety was formed.

Building Blocks of Safety

- What is the goal of the sessions?
 - To build a base for all future discussions
- Why start so basic?
 - There is a gap in fundamental understanding of how safety interacts with various aspects of programs.
- You can not change that which you do not understand.

New Business

- IIEC Request to Safety Committee
 - Loaded Containers Being Returned as Empties
 - The IIEC is asking the Safety Committee to review this industry issue and provide its recommendations on potential solutions.
 - Potential Course of Action:
 - Developing a process map that identifies the various points within the equipment move and at which points a potential failure can occur
 - Could be utilized as an educational tool for the industry
