Results of Safety Committee Member Survey

- Survey was conducted in November 2022, with 34 of 60 members responding. The results...
- **1. What would you like IANA's Intermodal Safety Committee to do for you?**
 - #1: Provide industry recommended [safety] practices
 - #2: Provide training and education
 - #3: Provide accident statistics and data around safety
 - #4: Provide regulatory updates

Results of Safety Committee Member Survey

- 2. Which of the following topics would you find most beneficial for educational programming?

#1: Safety technology and policies

#2: Training recommended practices

#3: Building blocks of a safety program

#3: Managing risk

#4: Behavioral-based safety

#5: Deposition preparation and verdict recommended practices

#5: JSAs, observations and Root Cause Analysis

Results of Safety Committee Member Survey

- 3. Do you find value in IANA's Intermodal Safety Committee remaining a stand-alone committee?

Yes: 73%

No: 12%

Not sure: 15%


Results of Safety Committee Member Survey

- 4. Would you be more likely to attend IANA's Business Meeting or Intermodal EXPO if there were safety-specific education and breakout sessions?

Yes: 68%

No: 15%

Not sure: 17%

IANA's Intermodal Safety Committee Roadmap

- Shift in Focus

- What is the goal of the Safety Committee?

Service it's members by providing education and information on those topics deemed important to the members.

- How are we doing?

The committee has not hit quorum in its last 3 meetings.

- What are the options to improve?

Roll the committee under the Operations committee as a standing working group.
Shift the focus of the committee to better improve participation.

IANA's Intermodal Safety Committee Roadmap

- **Current Topics**

- **What topics are the Safety Committee currently discussing?**

 - Terminal Traffic Safety

 - Data Collection

- **What kind of participation do the topics generate?**

 - Only a handful of companies have chosen to provide data for analysis.

 - Discussion with the larger committee members is weak as the topic does not lend itself to open discussion.

 - Data is considered sensitive due to competitive reasons or legality concerns.

IANA's Intermodal Safety Committee Roadmap

- What Should Change

- The Safety Committee should focus efforts on those topics most universal to our members.

- What it takes to reach Quorum.

Is it possible to reduce the required number to a more reasonable and sustainable requirement?

Should delegates be appointed to stand-in by absentee voting members?

- Create safety focused break-out sessions at both the Business and Expo

IANA's Intermodal Safety Committee Roadmap

• Committee Deliverables

- The Committee has delivered all current templates related to the Terminal Traffic Safety and Data Analysis working groups.
- In the future, deliverables in written form should not be the goal.
- Our focus should be on providing our members resources via networking and best practice to aid in the development of safety programs regardless of modality, operations or size.
